**TEMPORARY REDUCTION OF FILING FEES IN CERTAIN CIVIL ACTIONS**

The purpose of this directive is to lower the amount of uncommitted cash fund reserves required by section 24-75-402, C.R.S., by temporarily reducing certain civil action filing fees.

It is projected that the judicial stabilization cash fund, authorized under section 13-32-101(6), C.R.S., will exceed its statutory target reserve limit. Accordingly, and pursuant to section 13-32-105.5, C.R.S., and section 24-75-402(3), C.R.S., the Chief Justice is acting to bring the fund balance into compliance by temporarily reducing the stabilization fee charged in certain civil actions. Pursuant to section 24-75-402(4), C.R.S., the Chief Justice, as necessary, may later increase these fees back to their statutorily permitted level.

These temporary stabilization fee reductions are detailed in the tables attached as Appendix A and are effective on and after January 23, 2012.
